The contract comes into effect upon written acceptance by VDI Verlag.
VDI Verlag shall make a declaration of acceptance within 2 weeks.

TERMS AND CONDITIONS

1. Registration:

- a) Registrations must be made solely on this form. By signing the registration form the signatory accepts the General Terms and Conditions of VDI Verlag as binding.
- b) The COMPANY in the sense of these General Terms and Conditions shall be the legal entity or person in the name of which or whom the binding registration has been made and which or who has been accepted by VDI Verlag.

2. Admission:

VDI Verlag shall decide the on acceptance of the COMPANY's contractual offer and the admittance of exhibits as it may deem fit. VDI Verlag shall only refuse exhibits on the grounds of a good material cause.

3. Binding registration and cancellation:

By confirming registration for the Recruiting Day, participation shall be legally binding.

The COMPANY shall be entitled to cancel pursuant to the following terms and conditions:

- The exhibitor may cancel the booked services free of charge up to 6 weeks prior to commencement of the event.
- A charge of 75% of booked services shall be made for cancellations up to 3 weeks prior to commencement of event.
- A charge of 100% of booked services shall be made for cancellations after 3 weeks prior to commencement of event.

4. Set and equipment of exhibition stands:

- a) The exhibition spaced booked by COMPANY is made available and allocated by VDI Verlag.
- b) Equipment and design of the stand is the responsibility of COMPANY.
- c) COMPANY received instructions for set up and break down of the exhibition stands after registration.
- d) COMPANY is liable for damages to the exhibition hall and equipment incurred by its staff and contractors.

5. Advertising in the Fair & Exhibition Centre:

Print materials and advertising materials must be distributed only within the exhibition areas booked, not in the remainder of the exhibition centre. Exhibits may be shown in the remainder of the exhibition centre only following consultation and approval.

6. Cancellation of event:

VDI Verlag hereby reserves the right to cancel the VDI nachrichten Recruiting Day up to one month prior to commencement of the event, based on insufficient demand. In such a case, VDI Verlag hereby agrees to inform the COMPANY immediately of the cancellation. Any payments already made by the COMPANY shall in this case be reimbursed. Claims for damages by the COMPANY against the VDI Verlag shall in these cases be excluded.

If VDI Verlag is unable to hold the event due to force majeure or due to other occurrences which pose comparable risks or have comparable consequences, VDI Verlag must inform the company immediately. While the claim to a stand rent will in principle no longer apply, VDI Verlag may nonetheless charge for any expenses it has actually incurred for work commissioned from it. If VDI Verlag is able to hold the event at a later time, it must inform the company immediately. The company shall be entitled, within one week of receiving this notification, to cancel its participation on the changed date; in this case the company shall be entitled to a refund of the stand rent less any expenses incurred by VDI Verlag.

7. Liability:

VDI Verlag shall be liable to the COMPANY and its agents for any proven loss in the exhibition centre during the event only in cases of intention or gross negligence by staff of VDI Verlag GmbH, in case of breach of cardinal duties, in case of injury to life, limb or health, in case of fraudulent concealment of a defect, in cases of product liability, and insofar as a guarantee has been undertaken. Otherwise liability by VDI Verlag is hereby excluded.

The COMPANY shall be liable to VDI Verlag pursuant to statutory provisions.

COMPANY shall ensure that the stand equipment, the documents distributed at the stand and exhibits do not violate any third-party rights. If COMPANY books the advertising services, it shall also guarantee that it holds all the rights which are required for the purpose of placing the advertisement. If a claim is brought against VDI Verlag on the grounds of an (alleged) violation of such right, regardless of the legal grounds of such violation, COMPANY shall indemnify VDI Verlag against all such costs, including legal costs, on first demand. COMPANY shall support VDI Verlag in good faith with information and documentation in its legal defence against third parties.

Liability by VDI Verlag for lost goods or valuables is hereby excluded. VDI Verlag shall not be responsible for securing the exhibition centre outside the times of the event.

8. Granting of rights of use:

COMPANY shall grant VDI Verlag all the rights required for the contractual use of the logo on event materials and in advertising for the event in print and online media of all kinds, including the Internet, and including but not limited to the right to reproduce, disseminate, transmit, send, make publicly accessible, access from a database and call up.

9. Ancillary agreements:

No ancillary agreements have been made. Amendments and supplements to this contract must be in writing. This shall also apply to an amendment to the requirement of written form itself.

10. Place of jurisdiction:

The place of fulfilment shall be Düsseldorf, Germany. This shall also apply to the place of jurisdiction if the COMPANY is a full trader or legal entity under public law or has no general place of jurisdiction in Germany.
